Founded in 1978, the Florida Justice Institute (FJI) is a nonprofit public interest organization composed of dedicated lawyers, paralegals, and advocates who achieve widespread and lasting change through targeted and systemic civil rights litigation and advocacy."

Mission & Vision

We seek to improve to improve the lives of Florida's most vulnerable residents through impact litigation and advocacy, focusing on criminal justice reform, homelessness & poverty, and disability access. We envision a world without mass incarceration, and with racial and economic justice and human dignity for all Floridians.

Prisoners' Rights

We work toward criminal justice reform by representing incarcerated people in cases seeking to improve prison and jail conditions, giving a voice to these individuals in a system that largely ignores them.

Housing & Poverty
