About Florida Justice Institute

Florida Justice Institute (FJI) is a nonprofit, public interest law firm that uses impact litigation and advocacy to improve the lives of Florida's disenfranchised residents and underinvested communities, while focusing on human rights in the justice system, empowerment for vulnerable populations experiencing homelessness and poverty, dignity and access for people with disabilities, and related civil rights issues.

For over 45 years, FJI engaged in targeted civil rights litigation to achieve widespread and meaningful social progress. We have worked collaboratively with law firms, social justice organizations, and individuals to identify major, unmet needs in the community.

FJI works to end systems of oppression and improve living conditions for vulnerable populations across Florida. Though a combination of class action and individual cases, FJI leverages its legal expertise to pursue access to justice that transcend typical lawsuits.

FJI pursues criminal justice reform by representing incarcerated people in cases seeking to improve prison and jail conditions; giving a voice to these individuals in a system that routinely violates and denies their basic humanity.

We bring cases that catalyze the reform of Florida's inequitable criminal justice policies, including cases to improve prison conditions in areas such as medical and mental health care, abuse, violence, disability accommodations, free speech, dangerous understaffing, overcrowding, and solitary confinement.

FJI also seeks to alleviate poverty and advocates for the right to self-determination by encouraging smarter approaches to housing solutions while representing those experiencing homelessness and low-income residents in cases that seek to eliminate laws that criminalize someone's lifestyle, their identity or circumstances, and other social determinants. Additionally, we bring cases for victims of housing discrimination.

FJI works to ensure governments and businesses maintain accessible facilities, which enable people with disabilities receive the accommodations they need to earn a living wage with dignity and respect.

About The Event

On Thursday, April 17, 2025, we will award an individual with The Roderick N. Petrey Public Service Award, established in 2023 and named in honor of Florida Justice Institute's founder. The award recognizes individuals who have demonstrated distinctive support for public and social justice in the State of Florida. The 2023 recipient was Rod Petrey, the founder and first board chair of FJI.

The Social Justice Award will be renamed to the Randall C. Berg, Jr. Social Justice Award in honor of our first Executive Director and will recognize organizations demonstrating distinctive support for public and social justice in the State of Florida. The 2023 recipient was LEAP (Ladies Empowerment in Action Program) which empowers women who have experienced incarceration through transformational opportunities and advocacy.
