

About FJI

Our Story

The Florida Justice Institute, Inc. (FJI), was founded in 1978 by Roderick “Rod” N. Petrey, who remains a leading figure in securing funding for public interest law programs across the country. Upon leaving the Edna McConnell Clark Foundation in New York to enter the private practice of law in Miami, Rod was given a start-up grant to establish FJI.

Initial Mission

FJI’s mission, as established by Rod:

- Improve the administration of justice for all Floridians
- Encourage better representation of citizens’ interests
- Increase the ability of citizens to resolve disputes quickly and inexpensively

Rod and FJI set out to accomplish these goals by working with existing organizations to identify major, unmet needs in the community and address them through advocacy and litigation.

After incorporating the organization, establishing the Board, and obtaining section 501(c)(3) charitable status, FJI hired Randall C. “Randy” Berg, Jr., in 1978 to be its Executive Director, a position Randy held until his retirement at the end of 2018. Randy passed away in April of 2019.

Current Mission

FJI uses impact litigation and advocacy to improve the lives of Florida’s disenfranchised residents and underinvested communities while focusing on preserving human rights in the justice system, empowering vulnerable populations experiencing homelessness and poverty, and providing dignity for people with disabilities.

Vision

A world without mass incarceration, and with racial and economic justice and human dignity for Florida’s most vulnerable residents..

From our Executive Director:

Friends,

2025 is in the books, and 2026 is now upon us. Thank you to all who have supported our work!

2025 raised critical and, in some respects, unprecedented challenges for FJI and many other organizations within the legal aid ecosystem. As I told the Financial Times in April, “the legal system can create positive change in our communities but, in the wrong hands, can do more harm than good.”

As the saying goes, no one is above the law. At FJI, we believe that no one should be beneath it, either. That’s why the organization strives to deliver access to justice for Florida residents regardless of their identity, lifestyle, or circumstances. We remain steadfast in expanding that access to more communities around the state.

Our ability to do that depends on the availability of resources. Unfortunately, the organization is currently grappling with funding restrictions imposed in late 2024 by Funding Florida Legal Aid. Here are examples of these new restrictions:

- “Systematic advocacy for policy reform, legal reform, or civil rights initiatives unrelated to the representation of a specific low-income client”
- “Class actions where the government is a party”
- “Suits against state agencies and local government, other than matters seeking remedies for individual clients in eligible legal areas”
- “Facial challenges to existing laws or statutes”

This is why securing unrestricted funding from individuals, foundations, corporations, and other community organizations is crucial to providing relief to the most vulnerable among us in Florida. Your support enables FJI to increase its overall effectiveness.

In the midst of all the challenges, it’s still important to find ways to recognize and celebrate our successes. Even with all the heaviness, I’m proud of the colleagues and connections who helped positively shape these outcomes and so many more.

Unquestionably, our most impactful victory in 2025 was the passage of the Tristin Murphy Act, which officially became law in October. For those who may be unfamiliar, FJI represented the estate of the law’s namesake. This law unanimously passed through a combination of tireless advocacy by Tristin’s parents, Cindee and Dennis, and litigation brought by FJI.

You’ll see more highlights throughout this report, and we are confident we can make an even bigger impact in 2026. Your continued support enables FJI to be more resilient for the most vulnerable Floridians around the state. Access to justice requires that type of moral clarity.

We expect to keep making our supporters proud. Can we count on your contribution to help achieve new wins this year?

Our Year of Impact

January

PANEL

Miami-Dade Housing and Eviction Clinic

FJI participated in this clinic to support renters facing eviction by connecting them with legal information and on-site attorney assistance. The program centered on preventing housing instability and reducing harm caused by policies that criminalize poverty. FJI's ED Michael Langley contributed to a panel discussion focused on how advocacy and legal intervention can help keep vulnerable residents housed and protected.

February

CONFERENCE

Innovations and Solutions for Ending Unsheltered Homelessness (NAEH)

FJI joined national leaders, advocates, service providers, and people with lived experience to share best practices and emerging strategies to address unsheltered homelessness. Discussions focused on policy trends, system reform, and the growing criminalization of unhoused communities following recent court decisions. FJI engaged with peers to strengthen efforts pushing back against policies that further marginalize vulnerable Floridians.

PANEL

Impact Programs and Direct Legal Service Provider Engagement (FIU Law)

FJI participated in this panel to discuss how legal organizations coordinate services, identify gaps in capacity, and improve referral systems for people seeking help. The conversation emphasized access to justice through community-based education, collaboration, and advocacy. FJI shared insights from its work while engaging with legal partners committed to expanding meaningful legal support.

April

EVENT

Florida Legal Awards

FJI attended this statewide event recognizing leadership and impact within Florida's legal community. The gathering highlighted individuals whose work strengthens the legal ecosystem and advances justice across the state. FJI engaged with peers and partners to celebrate collaboration as a critical driver of community impact.

PANEL

Creating Opportunity for Returning Citizen Entrepreneurs (AEO)

FJI participated in this panel series examining entrepreneurship as a pathway to economic stability for returning citizens. The discussion explored how business ownership can reduce recidivism and expand opportunity when traditional employment barriers persist. FJI contributed to conversations on building trust, access to capital, and policy frameworks that support second chances.

May

EVENT

Innovations and Solutions for Ending Unsheltered Homelessness (NAEH)

FJI joined members of the legal, business, and civic community to celebrate efforts advancing equity and justice across South Florida. The evening highlighted leadership within the legal services community and recognized individuals driving meaningful change, including board member Tiffani Lee, who received the 2025 Equal Justice Leadership Award. FJI celebrated the contributions of its board leadership and reaffirmed its commitment to equal justice.

EVENT

Keep Hope Alive (Hosted by Americans for Immigrant Justice)

FJI attended this event honoring the resilience of immigrant communities and the organizations defending their rights. The gathering underscored the importance of due process and the rule of law amid increasing threats to vulnerable residents. FJI stands in solidarity with legal advocates working to protect immigrant families across Florida.

June

TRAINING

Intern Lunch & Learn: FJI Lunch and Learn

FJI hosted an educational session for interns and aspiring advocates interested in civil rights litigation. Participants learned about FJI's work, heard real-world examples of systemic injustice, and discussed pathways for building careers in public interest law. The session emphasized the ongoing need for legal advocacy and community engagement.

PANEL

Malcolm X Juneteenth Panel + Screening (Hosted by O Cinema)

FJI participated in this two-part event examining the state of civil rights and the work required to preserve them. The panel discussion connected historical movements with present-day challenges facing marginalized communities. FJI contributed to conversations centered on accountability, resistance, and the continued fight for equity.

SPEAKING ENGAGEMENT

HOPE Summer Fellows Class (Hosted by UM Law)

FJI partnered with the University of Miami School of Law to speak with students pursuing public interest careers. The session focused on building sustainable advocacy careers and working alongside communities impacted by the criminal legal system. FJI shared lessons from its work and encouraged students to pursue impact-driven legal pathways.

July

TRAINING

From Outreach to Access

FJI supported this community training focused on equipping advocates with tools to assist people experiencing homelessness. The session brought together local organizations to share practical strategies for outreach, navigation, and legal access. FJI contributed to efforts aimed at strengthening frontline advocacy and service coordination.

September

10th Anniversary Reception (South Florida People of Color)

Event Description: This event marked a decade of South Florida People of Color by honoring authentic storytelling, leadership development, and community connection. FJI leadership attended alongside state Sen. Shevrin Jones, who received the 2025 Political Leadership Award during the reception. Senator Jones was recognized for his legislative leadership, including co-introducing the Tristin Murphy Act during the 2025 Florida legislative session.

Welcome to the Judiciary Luncheon (Hosted by ACS South Florida)

FJI participated in this luncheon welcoming new members of the judiciary and fostering dialogue between legal professionals and constitutional advocates. The event emphasized relationship-building and civic education within the legal community. FJI engaged in conversations reinforcing its commitment to access to justice.

FJI attended this ceremony honoring excellence in ethics, leadership, and public service within the legal field. November

EVENT

Alvah Chapman Awards (GMCC)

FJI joined business and civic leaders to recognize individuals whose leadership has shaped Miami's economic and community development. During the event, FJI connected with long-standing partners committed to addressing unsheltered homelessness and advancing alternatives to incarceration. The evening underscored the role of sustained leadership and public-private collaboration in driving meaningful local change.

CONFERENCE

Bank on 100 Million Hackathon (Hosted by Mission Launch)

FJI participated in this national convening focused on developing practical reentry solutions for people with records. The hackathon brought together directly impacted individuals, technologists, employers, and government leaders to co-create tools that reduce barriers to employment and economic stability. FJI engaged with partners from across the country to advance strategies aligned with long-term criminal justice reform.

CONFERENCE

Human Rights in the Americas Symposium (Hosted by UM Law)

FJI staff attended a series of panels examining the intersection of human rights, democracy, and public policy across the Americas. Sessions focused on issues including the criminalization of homelessness, racial justice, and accountability within democratic institutions. The symposium provided FJI with updated legal and advocacy insights to strengthen its work on behalf of Florida's most vulnerable residents.

December

Desmond Meade Day Art of Impact

FJI participated in a celebration highlighting the power of second chances through art and storytelling. Held during Art Basel weekend, the event featured formerly incarcerated artists whose work reflects resilience, transformation, and civic impact. FJI joined community members and artists to honor Desmond Meade Day and the broader movement for dignity, restoration, and opportunity.


City of Miami Repeals its anti-panhandling law:




